Attention MIS Veterans--Your Help is Needed for the MIS Awards Database Project

Terry Shima, Metta Tanikawa, and others from the Japanese American Veterans Association (JAVA), are working on a project to document the awards received by the MIS during World War II, develop a national database, and give credit due to MIS soldiers for their work in helping to shorten the Pacific War during World War II.

Here's how you can help:

MIS Awards Project Background

The list of MIS Unit and Individual Awards (below) is based on information from about 800 of the 5,000-6,000 Japanese Americans who served as linguists in the Asia Pacific Theater. War Department officials expected the Nisei to be assigned to Regimental headquarters or higher for their safety and because their loyalty was questioned. Realities of combat, however, put a large number of Nisei in the combat zone. The Nisei soldiers had two goals: to help win the war and to prove their loyalty. They entered caves to persuade Japanese soldiers to surrender, translated documents, interrogated prisoners, monitored communications to pass real time intelligence information to combat commanders. Thirty-three Nisei linguists died in line of duty.

The MIS, as an organization, was not structured to maintain records of awards, as was the 442nd Regimental Combat Team. Publicity about the MIS, the US Army's "secret weapon," was not allowed until the 1970s.

The List of MIS Individual awards, although incomplete, 1) illustrates the large number of Nisei who were engaged in front line duties; 2) demonstrates Nisei willingness to fight soldiers of their parent's homeland, the acid test of loyalty to their nation; and 3) reflects Caucasian soldiers' change of attitude from initial to total support of Nisei.

Information for the list so far was drawn from various sources, including Army records, books, publications, veterans organizations, as well as veterans and their families. It is hoped that one day an organization can build on this "MIS Unit and Individual Awards" to achieve maximum accuracy. This MIS Unit and Individual Awards, a work in progress, is a tribute to the men and women who served as Japanese linguists during WWII.

We are fortunate to have a generous and supportive JACL membership base here in the Twin Cities. The energy of our chapter is greater than one might expect from our size. We do a great deal with a very limited budget. Did you know that of your \$65 family membership, \$60 goes to support the National JACL, \$3 goes to support the District JACL and only \$2 is kept to support our local chapter activities? Despite this we produce an annual family picnic, banquet, golf tournament and more.

In 2017, the 75th year anniversary of the signing of Executive Order 9066 and the mass incarceration of Japanese Americans, the Education Committee will be partnering with local institutions to bring several exhibits to commemorate what is euphemistically called “the internment” or “relocation.” We will be partnering with major Twin Cities institutions to bring you and our broader community a series of events.

1. **An exhibit of prints by renowned Japanese American artist Roger Shimomura**, incarcerated at Minidoka, which is planned for late January to late March, 2017 in the Law Warschaw Gallery, Macalester College. The Department of Art and Art History has enthusiastically embraced this project and is planning other educational programming around it. The TCJACL will be providing funds for half of the shipping, the speaker honorarium, outreach to the community and a reception. Shimomura lithographs have been exhibited at the Metropolitan Museum of Art in New York, the Smithsonian American Art Museum and other major art museums and institutions. His art includes the experience of internment and “often combines American popular culture, traditional Asian tropes, and stereotypical racial imagery to provoke thought and debate on the issues of identity and social perception.” (Wikipedia)

2. **A Day of Remembrance Ceremony** is scheduled for February 19, 2017 in the Auditorium of the Minnesota History Center. We are working with local theatre director Rick Shiomi to finalize a multi media staged testimonial program and with the Kogen Taiko drum group for a performance dedicated to the legacy of the incarceration. TCJACL will be providing a reception, community outreach which would include the Somali and Muslim communities, program brochure, and involve high school and college youth in the program. The Education Committee has procured a Legacy Grant of \$1,500 that will be applied towards this but does not cover the bulk of our expenses.

3. **A photo exhibit, *Gambatte***, by Paul Kitagaki is planned for display at Historic Fort Snelling from Memorial Day to Labor Day. This exhibit tells the before and after story of Nikkei whose pictures were taken during the World War II era by famed photographer Dorothea Lange (many of which have become iconic). Kitagaki juxtaposes current photographs of the same subjects or their survivors as a comparison. Captions on the impact of the unjust and unwarranted incarceration on their lives and where they are now will accompany the updated photos. The TCJACL will hold events related to the exhibit including the photographer, outreach to the community, a reception and informational program brochures.

The Committee welcomes the opportunity to partner with organizations to create programs that are free to the public. The combined budgets are anticipated to exceed \$20,000 but thanks to the generosity of our partners, our obligation is greatly reduced. However, even with Macalester’s significant support of the first exhibit, our Chapter’s obligation is \$1,850. Because the History Center and Kogen Taiko have waived various fees, our obligation is \$7,890 for the Day of Remembrance. As in the past, Historic Fort Snelling will be sharing costs for *Gambatte* as well but the cost to TCJACL Educational Programming is \$5,750 for this exhibit.

News from the Go For Broke National Education Center

National Park Service (NPS) Japanese American Confinement Sites Grant Award

Congratulations to the Go For Broke National Education Center in Los Angeles, CA, for being awarded a \$378,937 grant from the NPS Japanese American Confinement Sites program to fund its proposal titled, "Communities of Compassion and Courage." This collaborative historical and educational project highlights acts of courage and compassion extended to the Japanese American community by non-Japanese during and following World War II. The Twin Cities JACL was invited to be one of ten community partners for this project, and submitted a letter of support for the project.

Grant funds will be used to develop a traveling exhibit that explores courage and compassion towards Japanese Americans in the aftermath of Executive Order 9066. Traveling to the ten communities that are collaborating on this project, the exhibit will be supplemented with local artifacts, newspaper articles, and possibly oral histories of community members.

Local community partners will also develop lesson plans for middle and high school students to supplement the curricula developed by the Go For Broke National Education Center. The curriculum will be made available to schools, youth groups, and other organizations.

Our chapter is looking forward to this collaboration; the project is slated to get underway in Fall 2016.

Defining Courage Exhibition Opens to the Public

The Go For Broke National Education Center opened a new interpretive exhibition, *The Defining Courage Experience*, to the public in May 2016. Almost two dozen World War II veterans attended the grand opening of the exhibition on May 28, which was preceded by a solemn tribute ceremony at the Go For Broke Monument.

This one-of-a-kind, hands-on, participatory learning center in the heart of Los Angeles' Little Tokyo historic district explores the concept of courage through the lives of the young Japanese Americans of World War II, and asks modern visitors to act with similar courage in their own lives. The experience teaches the history of the Japanese American World War II story and its relevance to our lives today.

Governor Dayton Appoints Douglas C. Bayley and Jamie L. Cork to Fill First Judicial District Vacancies

ST. PAUL, MN – Today, Governor Mark Dayton announced the appointments of Douglas C. Bayley and Jamie L. Cork as District Court Judges in Minnesota's First Judicial District. Mr. Bayley is replacing the Honorable Thomas W. Bibus, and will be chambered at Red Wing in Goodhue County. Ms. Cork is replacing the Honorable Patrice K. Sutherland, and will be chambered at Hastings in Dakota County.

"It is my pleasure to appoint Mr. Bayley and Ms. Cork to serve as judges in the First Judicial District. They bring a diverse range of professional experiences and possess extensive records of public service," said Governor Dayton. **"I thank both of them for their desire to continue serving the people of Minnesota in these new roles."**

About Douglas C. Bayley

Mr. Bayley is an Assistant Public Defender in the First Judicial District Public Defender's Office, where he represents defendants in criminal cases. Previously, he was an attorney at Lundblad, Fossum & Zrimsek, a law clerk to the Hennepin County Public Defender's Office, and a Senior Duty Officer at the White House Situation Room and National Security Council, as a Foreign Service Officer in the U.S. Department of State. He earned his B.A. from Carleton College, his M.A. from the John Hopkins School of Advanced International Studies, and his J.D. from the University of Minnesota Law School.

Mr. Bayley serves on the Board of Directors for the Anderson Center at Tower View and the Hedin-Hartnagel Memorial Fund.

About Jamie L. Cork

Ms. Cork is an Assistant Hennepin County Attorney, where she works in the Child Protection Division. Previously, she was an adjunct professor at Hamline University School of Law and the University of St. Thomas School of Law, a counselor at Ryan Community, Inc., and a patrol officer in Outagamie County in Wisconsin. She earned her B.A. from Mount Senario College in Wisconsin and her J.D. from Hamline University School of Law.

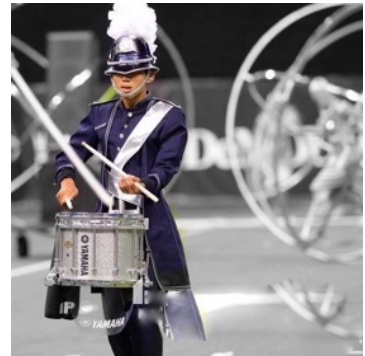
