History, appreciation and handling of the traditional Samurai sword will be taught by Mr. Tom Buttweiler.


From TC Chairman Chaplain:

INSTALLATION DINNER BANGET

The 1974 JACL Installation Dinner Banquet on Jan. 26th was held at Northwestern College, St. Paul, and featured Dave Ushio, National Director, as the main speaker. Tom Kanno, Toastmaster, proved a genial host, as hegreeted members and guest.

Bill Doi presented slides showing the history of the Japanese in America

May "Wounded Knee" Tanaka, in her second term as President, officially welcomed the membership, thanking them for their support in carrying out various programs during the year.

Our most welcome guest, Mr. Arnuf Ueland, Consul General to Japan, explained his duties and responsibilities. He made it perfectly clear that the title "Honorary" did not mean that honor is bestowed upon him, but that it meant no pay.

The keynote speaker, Dave Ushio, revealed some interesting facts regarding the curriculum material in California schools. Textbooks which had any sections on Japanese Americans presented erroneous impressions of Nisei and Sansei life in the U.S. A National JACL Education Committee works with the school systems in correcting these misinterpretations and in the selection of authoritative study material.

Dave also stressed the importance of being attuned to the needs of JACLers and in developing youth leadership. Since many of the national staff members are Sansei, this need is being supplied.

The highlight of his talk was his autobiography. Dave competed in the National JACL oratorical contest in 1964 at Detoit, served as a Mormon Missionary for 30 months in Japan and completed his college studies at Brigham Young University.

With his confidence and ability in dealing with today's JACL problems, and in working with government officials, Dave is proving himself a capable replacement to Mas Satow.

Following his address, Dave installed the 1974 chapter Boards.

Mr. Isao Takei, president, welcomed the guests, introduced his Board of Directors, and was Master of Ceremonies. The group delighted everyone with a variety of Japanese songs, including a recital of Shigin, and comedy skits, good ole Japanese swile.

JACL BUILDING

In 1972 our chapter voted against a permanent JACL building to be constructed in San Francisco at a cost of \$175,000. For two reasons: First of all, our chapter had a difficult time raising even \$300 (one dollar per member) for the Student Aid Program. I felt our chapter could not raise our share of the fund drive. Second, I believed our National Headquarters should be located in Washington D.C. Dave Ushio should serve as National Director as well as our Washington Representative (this is what he was trained for).

Late in 1972 the building project was approved. By the middle of 1973, I received another letter from Midwest District Governor which stated: We are committed to the construction of a building \$175,000 will not be sufficient. We were asked to approve a building fund drive of \$250,000. Again, our chapter voted "No" along with just 6 other chapters.

I have changed my views considerably since the fund drive began. It is gratifying to know so many JACLers donated so much towards a monument we will call our own.

Today, JACL's programs are becoming more issue oriented. They are making greater demands upon volunteers. Consequently, our National Staff is now comprised of 20 persons. We must adequately house our staff.

Now that the construction of a JACL office building in San Francisco has been overwhelmingly approved, our chapter should support the project.
